In continuation to the Department's letter of even No. dated 12.06.2014 wherein a Letter of Intent was issued to the college with respect to the proposals submitted to the Central Government as cited above, I am directed to say that after careful consideration of the recommendations of the C.C.I.M. in terms of the provisions of the IMCC Act 1970, relevant regulations of the CCIM and approved norms for the academic session 2014-15 vide Department's letter No.R.11011/10/2013-EP (IM-1) dated 17.06.2014 (available on Department's website <www.indianmedicine.nic.in>); permission of the Central Government is hereby granted to the Secretary, Himalayiya Ayurvedic Medical College & Hospital, Gram-Fatehpur Tanda, Post- Via Doiwala, Jeevanwala, Dehradun, Uttarakhand to start new post-graduate courses in 04 subjects viz. 

Further, to obtain the permission for academic session 2015-16 onwards to take admissions in the above said permitted courses and increased UG seats, college shall fulfil all the requirements of the IMCC Act, 1970 and the relevant Regulations made thereunder by 31.12.2014 and fulfilment of the conditions intimated by Department vide letter F.No.R.12011/13/2005-EP(IM-1) for 2014-15 dated 25.07.2014 will be verified by the CCIM.
